**1. The details of any change in the status and / or any development in relation to such proceedings:**

An FIR was filed in the Shastri Nagar Police Station, Jaipur bearing FIR No. 43 of 2018 on February 02, 2018 by Mr. Amit Dusad accusing the Promoters of the company, Mr. Sheikh Naseem and Mrs. Shivani Sheikh and certain others for abetment of suicide (under Section 306 of Indian Penal Code, 1860) committed by his brother, Late Ashok Dusad, an ex-director of the Company. The police investigated on the basis of FIR and filed a negative final report before the Additional Senior Civil Judge cum ACMM-1, Jaipur (Final Report/8126/2019 titled as *Amit Dushad vs. State Government*). The Hon'ble Court of ACMM-6, Jaipur Metro-2 has passed an order dated October 07, 2024 to dispose of the matter and return the case diary to the investigating officer. It has been noted that the complainant does not want to pursue the FIR which was filed under misconception.
